



Welcome to our Privacy Policy

-- Your privacy is critically important to us.

It is Carnival Connect's policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to www.thecarnivalconnect.com (hereinafter, "us", "we", or "www.thecarnivalconnect.com"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources.

This Privacy Policy, together with the Terms and conditions posted on our Website, set forth the general rules and policies governing your use of our Website. Depending on your activities when visiting our Website, you may be required to agree to additional terms and conditions.

Website Visitors

Like most website operators, Carnival Connect collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Carnival Connect's purpose in collecting non-personally identifying information is to better understand how Carnival Connect's visitors use its website. From time to time, Carnival Connect may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Carnival Connect also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on <http://www.thecarnivalconnect.com> blog posts. Carnival Connect only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

Gathering of Personally-Identifying Information

Certain visitors to Carnival Connect's websites choose to interact with Carnival Connect in ways that require Carnival Connect to gather personally-identifying information. The amount and type of information that Carnival Connect gathers depends on the nature of the interaction. For example, we ask visitors who sign up for a blog at <http://www.thecarnivalconnect.com> to provide a username and email address.

Security

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

Advertisements

Ads appearing on our website may be delivered to users by advertising partners, who may set cookies. Protection of Certain Personally-Identifying Information

Carnival Connect discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors, and affiliated organizations that (i) need to know that information in order to process it on Carnival Connect's behalf or to provide services available at Carnival Connect's website, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors, and affiliated organizations may be located outside of your home country; by using Carnival Connect's website, you consent to the transfer of such information to them. Carnival Connect will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors, and affiliated organizations, as described above, Carnival Connect discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when Carnival Connect believes in good faith that disclosure is reasonably necessary to protect the property or rights of Carnival Connect, third parties or the public at large.

If you are a registered user of <http://www.thecarnivalconnect.com> and have supplied your email address, Carnival Connect may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Carnival Connect and our services. We primarily use our blog to communicate this type of information, so we expect to keep this type of email to a minimum. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Carnival Connect takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Aggregated Statistics

Carnival Connect may collect statistics about the behavior of visitors to its website. Carnival Connect may display this information publicly or provide it to others. However, Carnival Connect does not disclose your personally-identifying information.

Cookies

To enrich and perfect your online experience, Carnival Connect uses "Cookies", similar technologies and services provided by others to display personalized content, appropriate advertising and store your preferences on your computer.

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Carnival Connect uses cookies to help Carnival Connect identify and track visitors, their usage of <http://www.thecarnivalconnect.com>, and their website access preferences. Carnival Connect visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before

Registration

Business Transfers
